ARTICLES OF INCORPORATION
OF

ROTARY CLUB OF FORT COLLINS, COLORADO, INC.
(A Nonprofit Corporation)

KNOW ALL MEN BY THESE PRESENTS: That the undersigned incorporators being natural persons of the age of twenty-one years or more and desiring to form a body corporate under the provisions of the Colorado Nonprofit Corporation Act do hereby sign, acknowledge and deliver in duplicate to the Secretary of State of the State of Colorado these Articles of Incorporation:

ARTICLE I

Name

The name of the Corporation shall be: ROTARY CLUB OF FORT COLLINS, COLORADO, INC.

ARTICLE II

Period of Duration

This Corporation shall exist in perpetuity, from and after the date of filing these Articles of Incorporation with the Secretary of State of Colorado unless dissolved according to law.

ARTICLE III

Objects and Purposes

The object and purpose for which the said Corporation is organized is to encourage and foster the ideal of service as a

basis of worthy enterprise and, in particular, to encourage and foster:

1. The development of acquaintance as an opportunity for service;

2. High ethical standards in business and professions; the recognition of the worthiness of all useful occupations; and the dignifying by each member of his occupation as an opportunity to serve society;

3. The application of the ideal of service by every member to his personal, business and community life; and

4. The advancement of international understanding, goodwill, and peace through a world fellowship of business and professional men united in the ideal of service.

The enumeration of the foregoing object and purpose shall not be construed to limit or restrict in any manner the general powers and rights of the Corporation as provided by law.

ARTICLE IV

Registered Office and Registered Agent

The address of the initial registered office of the Corporation is 3024 Regatta Lane, #1, Fort Collins, Colorado 80525, and the name of the initial registered agent at such address is Bert Vickery. Either the registered office or the registered agent may be changed in the manner permitted by law.

ARTICLE V

Initial Board of Directors


